By my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of myself, patrons, owners, members, agents, officers, employees of Blast om LLC, or any other person.

Phazertag Safety Rules

All PLAYERS MUST FOLLOW All SAFETY AND GAME RULES WITHOUT EXCEPTION.

Any violation of these rules will result in that player being ejected from play and/ or the premises, at the sole option of the management, without a refund.

1. Safety goggles must be worn at ALL times.
2. No shooting at the neck or head.
3. No shooting outside of arena, this includes the vesting room.
4. All guns must have a safety on and barrel plugs in while outside of the arena.
5. Guns may not be taken outside playing area.
6. No climbing on structures of any kind.
7. No physical contact.
8. No outside gear can be brought into the arena.
9. No profanity, sexually offensive or racial remarks will be tolerated.
10. Do not attempt to remove or adjust the CO₂ bottles or any parts from the guns.
11. Marshals decisions are final. No players will be allowed to argue with any judge.
12. No shooting at marshals.
13. No shooting within 10 feet of opponent.

AS A PLAYER, I WILL CONFORM TO ALL OF THESE RULES AND I UNDERSTAND THE CONSEQUENCES IF THEY ARE NOT FOLLOWED.
